2. Billing Procedures

Invoices are sent on the 1st of each month based on the tutor's recorded hours in TutorBird. I understand that TutorBird is the official record of tutoring sessions, and whatever is recorded there is what will be billed. It is my responsibility to verify with the tutor that the TutorBird calendar is accurate before the 1st of the month. I agree to pay the full invoiced amount each month. Partial payments will not be accepted, and tutoring may be paused until payment is complete. All billing questions or disputes must be handled directly with Love 4 Learning LLC. Tutors do not manage billing and should not be contacted about payments.

3. Scheduling & Cancellations

I will work directly with the tutor to schedule sessions. I agree to provide at least 48 hours' notice for any cancellations. Late cancellations will result in being billed for the full session. If someone in my household is sick, I agree to cancel the session as soon as I am aware to avoid charges. Love 4 Learning LLC agrees to cancel any in-home session if someone in their household is sick.

4. Attendance Requirement

My child must maintain at least 80% attendance per quarter. If this requirement is not met, our tutoring slot may be reassigned to another student.

All tutors are independent contractors contracted through Love 4 Learning LLC. Tutors are required to have a valid Arizona Fingerprint Clearance Card and pass a background check. I agree to hold Love 4 Learning LLC harmless for any concerns or claims arising from services provided by the tutor.

6. Communication & Learning Environment

I will ensure a quiet, safe, and respectful environment during sessions. Communication about scheduling or concerns will be with the tutor and/or Love 4 Learning LLC as appropriate.

7. Tutor Substitution and Change Requests

If a tutor becomes unavailable, Love 4 Learning LLC may assign a substitute with similar qualifications. I may request a different tutor if needed for my child's success.
